The Finance Committee met on Tuesday, January 17, 2023. The following committee members were present: Tim Matlick, Craig Melville, Luke Holocher, Deb O'Neill, Kathy Seybert, Allycia Taussig, Julie Jordening, Flavio Quintana, and Agnessa Vartanova.

Financials Update: The financials through December 2022 were reviewed with no issues noted. The amended budget's changes were discussed and will be presented for Board approval at the January 2023 meeting.

New Budget Dashboard: The financial team at JA has been working on a new financial dashboard that will be provided to the Board at its regular meetings. The new dashboard provides an executive overview of the finances at JA. The financial team estimates the new dashboard will be available for the February 2023 Board meeting. This is excellent work by all involved!

Jeffco's administration has notified charter schools of some changes for the next school year. JA will have to pay for its own risk management insurance and conduct its own Title Nine investigations. JA's administration is assessing these financial and human resource impacts and will provide more information later this spring. While the changes were presented as finalized, Jeffco's administration agreed to go back and internally discuss the impacts brought up by charter schools.

We are currently working on re-enrollment like everyone else. We are excited to see so many tours being scheduled by families interested in SAS. At the beginning of the month, we had a field trip to the DMNS and we had a lot of families attend. It is a great community building experience. Currently we are working on planning more community building activities. In the classroom, we are working on implementing and perfecting our

craft to align with the core values or JA. Teachers are coming up with amazing class ideas for the 2023-24 school year. It is so exciting to see!

Executive Director's Report

State & JeffCo Enrollment Projections:

In December at the Executive Leadership Meeting, Jeffco's CFO and Superintendent presented enrollment projections for the coming years. Two interesting points were presented:

- Over the last couple of years, Jeffco enrolls about 4,500 kindergarten students and graduates about 6,500 students
- For the 2023-34 school year, Jeffco is projecting a 1.5% loss of enrollment at the elementary level (no secondary information was presented)

Statewide enrollment trends published in January are also quite interesting:

- Over 2 years kindergarten enrollment dropped by 2,373 students (3.8%)
- Homeschool student enrollment dropped by 2,622 students over the last 2 years
 - Total Homeschool enrollment 10,052 to 7,880
 - I'm not confident this is accurate as some families don't submit the required "Intent to Homeschool" letter to their district or other provider
 - If these numbers are accurate, JA/Summit would be hosting 12.7% of all homeschooled students statewide
- Charter school enrollment is up 2,500 over the last 2 years (135,000 total)

Changes to Jeffco's Service Offerings:

On January 10th, Jeffco held a meeting for charter schools in which they announced that starting next year they would no longer offer Risk Management (Insurance) to charters as a purchased service. Their new counsel believes that it creates too much exposure for the district. On the positive side, Risk Management is working with their current underwriter to help put together a group package for Jeffco charters that could result in better coverage at lower premiums. We have also identified 3 other carriers that provide insurance to non-Jeffco charters. The downside is that when purchasing insurance through Jeffco, we have always been able to approach situations as partners. I am very disappointed in the decision especially since this went to Cabinet for a determination without notifying charter schools.

Another change is that Jeffco determined charter schools will need to provide their own primary contact for Title IX issues that may arise. Once again, until now we have been able to partner with the district to navigate these situations together. I will continue working with our Community Superintendent as we work with the changing landscape.

Jeffco Charter School Consortium (JCSC):

As a result of the situation outlined above, the JCSC has called a meeting for Tuesday, January 31 at 5:00 pm. The meeting will be held at Addenbrook Classical Academy. The purpose of the JCSC has always been to bring Jeffco charters together in order to speak with one voice and develop partnerships with the district. The JCSC is open to school leaders, board members and other interested parties. On Thursday I forwarded an email to you with more information about this meeting.

Secondary Principal Hiring Process:

The open secondary principal position was posted on Thursday, January 12th. As of the writing of this report, we have received 12 applications. I am working with Ms. Porreco and Ms. Fox to develop the committee process, guidelines and flow chart that we will be using. Current plans are to include stakeholder representation/input to help inform the decision making process. More information will be provided as we refine and begin finalizing the timeline.
