1. Audit

The Replication Application for Coal Creek Canyon K-8 was approved unanimously by the Board during the November meeting. This application marks an important milestone in the establishment of a JA campus at Coal Creek Canyon K-8. Adding Coal Creek Canyon K-8 into the JA portfolio fits well within our mission and vision, and we look forward to the opportunity to serve the Coal Creek Canyon community.
